

## Illegal Behavior

Includes but is not limited to:

- **Assault**
- **Criminal Mischief**
- **Drunk or Disorderly Conduct**
- **Harassment**
- **Public Lewdness**
- **Theft (Larceny)**
- **Trespass**
- **Controlled Substance or Alcohol**
- **Public Urination**

**Any patron who engages in illegal behavior on library premises will be permanently banned.**

Abusive, argumentative words and/or behavior towards library staff are deemed inappropriate and grounds for one verbal warning and may result in loss of library services.

The Columbia Public Library Board of Directors has established certain standards of acceptable behavior on library property in order to maintain an atmosphere that promotes the use and enjoyment of the resources and services of the library, promotes the library, promotes the safety of the general public and the library staff, and protects the building, furniture, equipment, and materials of the library.

Any activity that interferes with the rights of other patrons to use the library, disrupts the normal functioning of the library, could result in physical, emotional, or mental injury to oneself or others, or could result in damage to the facilities, equipment, or materials is considered disruptive and unacceptable behavior.

The library reserves the right to require anyone who engages in disruptive behavior to leave the premises, the right to restrict privileges for a specified period of time or permanently. In most cases, a staff member will notify the individual that he or she is in violation of the standards of conduct and will provide one verbal warning. Unlawful activities will be reported immediately to the police.

# Patron Conduct Policy

**Library use is limited to three hours per patron, per day.**

**Charging personal devices is limited to a maximum of three (3) hours per day. This limit applies inside and outside of the library building.**

**Library Staff may request a patron unplug their device(s) at any time.**

The library is **NOT** responsible for personal items that are lost, stolen, or damaged on library property.

The following are **NOT** permitted at the Columbia Public Library:

**Sleeping.**

**Hygiene.** A person may be requested to leave the library if his/her personal hygiene interferes with the orderly operation of the library or with the ability of the other patrons to use and enjoy the facility.

**Misuse of Restrooms.** Includes excessive visits or using the restrooms as a laundry or bathing facility. **Must** have ID or library card to use restroom.

**Food and Drink.**

**Loitering.** It is defined as a person who is monopolizing library space without using the library's resources.

**Animals.** Animals of any kind are prohibited, unless serving as an ADA stipulated assistance animal or part of a library-sponsored program.

**Unattended Children.** A parent, guardian, or other responsible adult must always accompany children under the age of 8 in the library.

**Attire.** Patrons must wear shoes and shirt in the library building.

**Abuse of Library Equipment, Furniture, and Materials.**

**Abusive or Obscene Language or Gestures.** Includes language or gestures that convey sexually specific messages or are conveyed in a coarse or crude manner and any language that verbally abuses another individual.

**Boisterous Behavior.** Includes running, horseplay, and annoying other patrons.

**Fighting.** Includes any kind of fighting, real or pretend.

**Cellular or portable phones.**

Conversations **MUST** take place outside of the library.

**Weapons.** Carrying weapons of any type on library property is not permissible except by law enforcement officials.

**Removing Library Materials or Equipment.** Staff members must check out all circulating materials before they can be removed from library property.

**Playing Music.**

**Excessive Displays of Affection.** Includes any sexual conduct or physical contact deemed inappropriate for a public place.

**Bikes, Rollerblades, Skateboards, and Scooters.** Must not be ridden anywhere on the library property.

**Excessive Amounts of Personal Items** including but not limited to; large or multiple bags, strollers, or other large, wheeled conveyances are not permitted inside the library building.

**NO Solicitation.**

**Loud Talking and Laughing.**

**Smoking.**

**Throwing Objects.**
